# EMERGENCY MEDICAL CARE & SCOPE OF PRACTICE

#### **KEY FINDINGS**

- 1. Doctors/physicians are the most familiar and trusted medical professionals among adults to lead medical care in a medical emergency.
  - Older adults hold a higher preference for doctors/physicians than their younger counterparts.
- 2. The majority of adults expressed they would be concerned if a doctor/physician was not available to lead their emergency medical care.
  - Roughly one-quarter of adults expressed they would not be concerned if a doctor/physician was not available to lead their emergency medical care.
- 3. Although most adults support expanding scope of practice for APPs, a high proportion of adults do not know about or have no opinion on the topic.
- 4. Adults still overwhelmingly prefer a doctor/physician over the other medical professionals to lead their emergency medical care even after learning about education.
  - Learning about the amount of education and training required for each of the medical professionals had little influence on adults' preference of who should lead their emergency medical care.



SCOPE OF PRACTICE



Adults are most familiar with doctors/physicians and registered nurses in an emergency department. Over half of adults (52%) felt *very familiar* with the role of a doctor/physician while only one-third of adults (35%) felt *very familiar* with the role of a physician assistant in an emergency department.



#### SCOPE OF PRACTICE



Eight-in-ten adults (79%) prefer a doctor/physician to lead their medical care while in the emergency department. Very few adults prefer any of the other medical professionals to lead their emergency department medical care.

In the event of a medical emergency, who of the following do you prefer most to lead your medical care (diagnosing and treatment) while in the emergency department?




Nine-in-ten adults 65 and over (91%) prefer a doctor/physician to lead their medical care in the emergency department whereas only two-thirds of adults aged 18-34 (67%) prefer a doctor/physician to lead their emergency department medical care.

Nearly three-fourths of adults (72%) would be *very* or *somewhat* concerned if a doctor/physician was unavailable to oversee their diagnosing and treatment in a medical emergency.


How concerned would you be, if at all, about the quality of your medical care if there were not a doctor/physician overseeing your diagnosing and treatment in a medical emergency?








Over half of adults (53%) believe the scope of practice for APPs should be expanded, although nearly three-in-ten adults (29%) expressed they did not know or had no opinion.









# Adults across all demographics have a lack of knowledge on whether scope of practice for APPs should be expanded.

APPs include non-physician medical providers such as physician assistants and nurse practitioners Which of the following comes closest to your opinion, even if neither is exactly correct?



After learning more about the training requirements for each of the medical professionals, adults still preferred a doctor/physician to lead their medical care in the emergency department.

As you may know, a physician assistant (PA) is required to complete 7 years of training and 1,600 clinical hours to be licensed. A nurse practitioner (NP) is required to complete 5-8 years of training and 500 clinical hours to be licensed. A registered nurse (RN) is required to complete 4 years of training and 400 clinical hours to be licensed. A doctor/physician (MD/DO) is required to complete 11 or more years of training, a medical residency, and 12,000 clinical hours to be licensed. After learning more about the training for each medical professional, which of the following medical professionals do you prefer most to lead your medical care (diagnosing and treatment) in a medical emergency?



After learning more about the training requirements for each of the medical professionals, older adults still show more preference for a doctor/physician to lead their emergency medical care than younger adults.
